

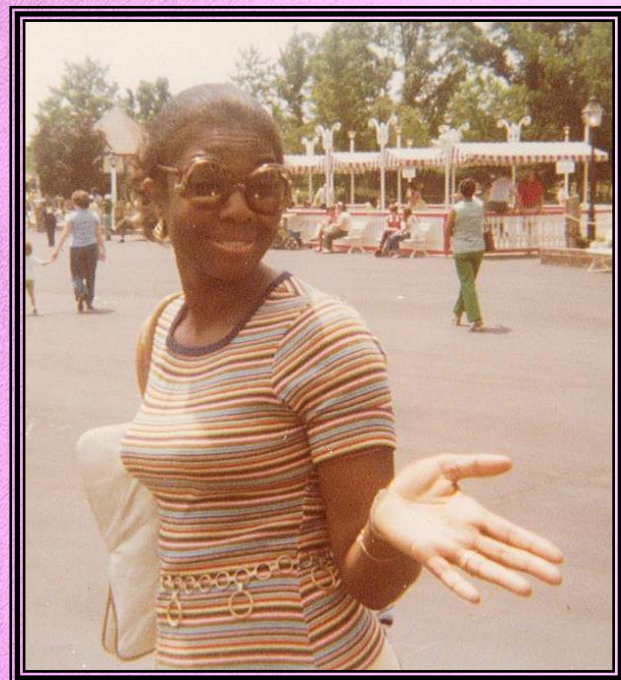
## *The End of The Road*

# Obituary

## of Mrs. Pearl Glover Bonner

Mrs. Pearl Glover Bonner, daughter of the late Stroman Glover and the late Earsia Lewis Glover was born in Calhoun County, on October 19, 1932. She closed her eyes and began her eternal rest on Monday, September 9, 2024, at Longwood Plantation Assisted Living Facility, Orangeburg, South Carolina.

Pearl’s life mantra: “Do all the **good you can**, by all the means you can, in all the ways **you can**, in all the places you **can**, at all the times you **can**, to all the people you **can**, as long as you **can**.” Pearl was united in holy matrimony to Joel Hampton Bonner, Jr. in 1955.
